Within the limitations of state and federal law, adequate information must be provided by the 2 mental health institutes and the department to the institute councils to perform their duties, including but not limited to: 4 6 A. Input into the annual budgets of the mental health institutes; 8 B. Achievement of the goals and objectives of the department as they pertain to the mental health institutes; 10 C. Compliance with all professional accreditation standards 12 applicable to the mental health institutes; 14D. Review, oversight and assessment of services and programs provided to residents of the mental health institutes and 16 their families; 18 E. Review of personnel policies and employment patterns, 20 including staffing requirements and patterns, the use of overtime assignments and training and job development; 22 F. Input into public relations efforts of the department and 24 the mental health institutes and community education initiatives; and 26 G. Monitoring building and grounds maintenance and safety and risk management on the campuses of the mental health 28 institutes.' 3.0 Further amend the bill by inserting at the end before the 32 summary the following: 3.4 **'FISCAL NOTE** 36 The Department of Mental Health, Mental Retardation and

38 Substance Abuse Services will incur some minor additional costs associated with expanding the responsibilities of the two institute quality improvement councils. These costs can be absorbed within the department's existing budgeted resources.'

## SUMMARY

46 This amendment replaces the bill. It changes the title. It clarifies and adds to the responsibilities of the mental institute quality improvement councils established by the Department of Mental Health, Mental Retardation and Substance 50 Abuse Services, giving them evaluation and advice functions
