30 Further amend the amendment in the 3rd indented paragraph on page 2 in the last line (page 2, line 19 in amendment) by 32 striking out the following: "section 7" and inserting in its place the following: 'sections 7 and 8'

Further amend the amendment by inserting after the 3rd indented paragraph on page 2 the following:

38 'Further amend the resolve in section 9 in the 3rd line from the end (page 3, line 49 in L.D.) by striking out the following: 40 "Expenditures" and inserting in its place the following: 'Except as provided under section 8 of this resolve, expenditures' '

Further amend the amendment on page 2 in section 10 by striking out the first 3 lines (page 2, lines 28 to 30 in amendment) and inserting in their place the following:
