HOUSE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to S.P. 429, L.D. 1377, "Resolve, to Establish a Maine Mobility Fund Task Force"

Amend the amendment by inserting after the first indented paragraph on page 2 the following:

'Further amend the resolve in section 8 in the last line (page 3, line 32 in L.D.) by inserting after the following: "compensation" the following: 'except that the members of the task force who are Legislators are entitled to receive the legislative per diem as defined in the Maine Revised Statutes, Title 3, section 2 and reimbursement for travel and other necessary expenses for attendance at meetings of the task force'

Further amend the amendment in the 3rd indented paragraph on page 2 in the last line (page 2, line 19 in amendment) by striking out the following: "section 7" and inserting in its place the following: 'sections 7 and 8'

Further amend the amendment by inserting after the 3rd indented paragraph on page 2 the following:

'Further amend the resolve in section 9 in the 3rd line from the end (page 3, line 49 in L.D.) by striking out the following: "Expenditures" and inserting in its place the following: 'Except as provided under section 8 of this resolve, expenditures'

Further amend the amendment on page 2 in section 10 by striking out the first 3 lines (page 2, lines 28 to 30 in amendment) and inserting in their place the following:


