Further amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

The amendment conforms the Maine Revised Statutes, Title 30-A, section 5706, subsection 2 with Part B of the bill and recognizes an alternative means by which municipalities investing in repurchase agreements may acquire an interest in United States Government obligations. The amendment also deletes an unnecessary section and makes numerous technical changes.
