The Legislature will require an additional General Fund appropriation of \$4,660 in fiscal year 1998-99 for the per diem and expenses of certain members and miscellaneous costs of the Maine Forest Policy Round Table Study Commission. The Legislature will also require General Fund appropriations of \$4,660 in fiscal year 1999-2000 and \$8,645 in fiscal year 2000-01 for continued per diem and expense costs, public hearing costs and miscellaneous costs, including printing the report.

The additional costs associated with providing staffing assistance to the commission can be absorbed by the Legislature utilizing existing budgeted resources during any interim between sessions. If the commission requests staffing assistance during legislative sessions, the Legislature will require additional General Fund appropriations for contracted staff services.

34 36 The Department of Conservation will incur some minor additional costs to participate on the Maine Forest Policy Round Table Study Commission. These costs can be absorbed within the department's existing budgeted resources.'
