An Act to Fund the Collective Bargaining Agreement for the Law Enforcement Services Bargaining Unit.

Presented by Speaker MITCHELL of Vassalboro. (GOVERNOR'S BILL) Cosponsored by Senator DAGGETT of Kennebec and Representatives: MADORE of Augusta, O'BRIEN of Augusta, Senator: HALL of Piscataquis. **Emergency preamble. Whereas,** Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, certain obligations and expenses incident to the operation of state collective bargaining agreements will become due and payable immediately; and

Whereas, it is the responsibility of the Legislature to act10upon those portions of collective bargaining agreementsnegotiated by the executive branch that require legislative12action; and

Whereas, the Governor and the Legislature share a desire to address in a timely manner the needs of certain state employees
excluded from collective bargaining units; and

18 Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of 20 Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and 22 safety; now, therefore,

- 24 Be it enacted by the People of the State of Maine as follows:

Sec. A-1. Costs to the General Fund. There is appropriated in Part B of this Act funding sufficient when combined with other available funds to cover the costs to the General Fund in the amount of \$180,775 for the fiscal year ending June 30, 1997; in

32 the amount of \$188,176 for the fiscal year ending June 30, 1998; and in the amount of \$381,410 for the fiscal year ending June 30, 1999 to implement the economic terms of the collective bargaining agreement made by the State and the Maine State Employees 36 Association for the law enforcement services bargaining unit.

38 Sec. A-2. Costs to the Highway Fund. There is allocated in Part B of this Act funding sufficient when combined with other available funds to cover the costs to the Highway Fund in the amount of \$2,500 for the fiscal year ending June 30, 1997; in the amount of \$6,100 for the fiscal year ending June 30, 1998; and in the amount of \$12,300 for the fiscal year ending June 30, 1998; and in the amount of \$12,300 for the fiscal year ending June 30, 1999 to fund salary and benefit changes of the collective bargaining agreement made by the State and the Maine State Employees Association for the law enforcement services bargaining unit.

48 Sec. A-3. Special account funding. Funding provided by this Act must be segregated into a special account to be made available as
50 needed upon the recommendation of the State Budget

Officer with the approval of the Governor. The funds must include retirement costs. Positions supported from sources of funding other than the General Fund and the Highway Fund must be funded whenever possible from those other sources.

Sec. A-4. Lump-sum payment. A lump-sum payment equal to 2.25% of the employee's base rate paid for the first 26 paychecks in calendar year 1996 must be paid to each employee included in the law enforcement services bargaining unit, consistent with the terms of the collective bargaining agreement. This sum is not earnable compensation under the Maine State Retirement System.

Sec. A-5. Adjustment of salary schedules for fiscal year 1997-98. 14 Effective at the beginning of the pay week commencing closest to July 1, 1997, the salary schedules for employees in the law 16 enforcement services bargaining unit must be adjusted by 2%, consistent with the terms of the collective bargaining agreement. 18

Sec. A-6. Adjustment of salary schedules for fiscal year 1998-99. 20 Effective at the beginning of the pay week commencing closest to July 1, 1998, the salary schedules for employees in the law 22 enforcement services bargaining unit must be adjusted by 2%, consistent with the terms of the collective bargaining agreement.

Sec. A-7. Adjustment of mileage allowance. Consistent with the terms of the collective bargaining agreement, the mileage allowance rate for employees in the law enforcement services bargaining unit must be increased to 23¢ per mile effective July 1, 1997 and 24¢ per mile effective July 1, 1998.

Sec. A-8. New employees; similar and equitable treatment. Employees in classifications included in the law enforcement 32 services bargaining unit who are excluded from collective bargaining pursuant to the Maine Revised Statutes, Title 26, 34 section 979-A, subsection 6, paragraphs E and F must be given similar and equitable treatment on a pro rata basis to that given 36 employees covered by the collective bargaining agreement, except that nonstatus employees in acting capacity, intermittent or 38 project positions may not receive any lump-sum payment provided 40 in section 4 of this Part.

44 Sec. B-1. Transfer from salary plan. The salary plan program in the Department of Administrative and Financial Services may be 46 made available as needed in allotment by financial order upon the recommendation of the State Budget Officer and the approval of 48 the Governor to be used for the implementation of the collective bargaining agreement for state employees in fiscal years 1996-97, 50 1997-98 and 1998-99.

Sec. B-2. Carrying clause. Any balances remaining in the 2 General Fund and the Highway Fund salary plan accounts in the Department of Administrative and Financial Services may not lapse 4 but must be carried forward to June 30, 1999 to be used for the 6 purposes of this Act. Sec. B-3. Authorization for reimbursement of costs associated with 8 contract resolution. The Department of Administrative and Financial Services may be reimbursed from the special accounts funded by 10 this Act for the costs of contract resolution, administration, implementation and other costs required by the process of 12 collective bargaining and negotiation procedures. 14 Sec. B-4. Appropriation. SUMMARY

2 Part A of the bill provides funding and implementation of the cost items in the collective bargaining agreement reached 4 between the State and the Maine State Employees Association for 6 employees in the law enforcement services bargaining unit. 8 It reflects the costs from the General Fund to fund the 1. bargaining agreement. 10 2. It provides for the adjustment of salary schedules in 20 5. fiscal year 1997-98 for bargaining unit members. 22 6. It provides for the adjustment of salary schedules in fiscal year 1998-99 for bargaining unit members. 24 26 7. It provides for the increase in mileage allowance to 23ϕ per mile effective July 1, 1997 and 24¢ per mile effective July 28 1, 1998. It provides for similar and equitable treatment of 30 8. probationary and other employees in classifications in the law enforcement services bargaining unit. 32 Part B of the bill provides for appropriations from the 34 General Fund and allocations from the Highway Fund for Part A of this bill and provides for the transfer of funds from the salary 36 plan to be used for the implementation of the collective bargaining agreement. It also provides that funds appropriated 38 under this bill carry over until June 30, 1999, and provides for reimbursement to the Department of Administrative and Financial 40 Services for costs incurred in the process of collective bargaining, contract administration and related costs. 42
