SENATE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 1125, L.D. 1581, Bill, "An Act to Improve the Child Development Services System and Encourage Collaboration in Early Childhood Programs with School Administrative Units"

Amend the amendment in section 21 in subsection 2 in the first line (page 2, line 40 in amendment) by striking out the following: "18" and inserting in its place the following: '16'

Further amend the amendment in section 21 in subsection 2 in paragraph A in the first line (page 2, line 43 in amendment) by striking out the following: "Six" and inserting in its place the following: 'Four' and in the 2nd line (page 2, line 44 in amendment) by striking out the following: "4" and inserting in its place the following: '2'

Further amend the amendment in section 21 by inserting after subsection 5 the following:

'6. Meetings. The task force may meet up to 3 times.'

Further amend the amendment by striking out all of section 22 (page 4, lines 10 to 35 in amendment) and inserting in its place the following:

'Sec. 22. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.
