SUMMARY

This amendment changes the bill title and limits the application of the bill to egg processing facilities that have over 500,000 laying birds and that employ more than 100 agricultural employees. This amendment prohibits agricultural employers governed by the bill from locking out their employees and prohibits their employees from striking.
