Be it enacted by the People of the State of Maine as follows:

Sec. 1. 30-A MRSA §287, sub-§4, as enacted by PL 1993, c. 27, §1, is amended to read:

6 4. Standardized kit for evidence collection in cases of gross sexual assault. The Department of Public Safety shall determine by rule what constitutes a standardized kit for 8 evidence collection in cases of gross sexual assault. А physician, sexual assault nurse examiner or other health care 10 professional who conducts a physical examination of an alleged victim of gross sexual assault shall use a standardized evidence 12 collection kit that meets the requirements established by rule of 14the Department of Public Safety.

16 Evidence collection results may not be excluded as evidence in any proceeding before any court of this State as a result of the 18 failure to use the standardized evidence collection kit required by this subsection.

Sec. 2. 32 MRSA §2102, sub-§10 is enacted to read:

10. Sexual assault nurse examiner. "Sexual assault nurse examiner" means a registered nurse who has completed the required education and clinical experience and has been licensed by the board as provided under section 2205-C to conduct forensic examinations of victims of sexual assault.

Sec. 3. 32 MRSA §2205-C is enacted to read:

<u>§2205-C. Standards for licensing of sexual assault nurse</u> examiners

341. Minimum standards.The board shall establish rulesregarding the standards and procedures for licensing sexual36assault nurse examiners. These rules must, at a minimum, specify:

- 38 <u>A. Educational and clinical experience requirements for sexual assault nurse examiners;</u>

- B. Other appropriate educational skills and experience
 42 requirements for sexual assault nurse examiners;
- 44 C. The process through which registered nurses may apply to the board to be licensed as sexual assault nurse examiners;

E. Methods and procedures of monitoring the efficacy of licensing requirements for the sexual assault nurse examiners.
