COMMITTEE AMENDMENT "H" to H.P. 1190, L.D. 1689, Bill, "An Act to Provide Court-ordered Income Withholding of Spousal Support"

Amend the bill in section 1 in that part designated "**§954**." 24 in subsection 1 in the 5th line (page 1, line 11 in L.D.) by striking out the following: "<u>Income</u>" and inserting in its place 26 the following: '<u>Except as provided in chapter 65, subchapter IV, income'</u>

Further amend the bill in section 1 in that part designated 30 "<u>§954.</u>" in subsection 1 in paragraph D in the 8th to 12th lines (page 2, lines 24 to 28 in L.D.) by striking out the following: "For implementing the order to withhold, the payor is entitled to 32 charge a processing fee as adopted by the commissioner under 34 section 2370. This charge must be deducted from the amount withheld prior to its remittance to the department. The amount specified in the order" and inserting place the 36 in its 'The payor may withhold a \$2 processing fee in following: addition to the amount withheld for support. The amount withheld' 38

	10	The additional costs associated with recording and disbursing certain spousal support payments can be absorbed by
	12	the Department of Human Services utilizing existing budgeted resources.

	16	The additional workload and administrative costs associated with the minimal number of new cases filed in the court system can be absorbed within the budgeted resources of the Judicial
	18	Department. The collection of additional fines may increase General Fund revenue by minor amounts.'

	22	SUMMARY
	24	This amendment clarifies that when a court orders both spousal support and child support, the income withholding
	26	provisions of the Maine Revised Statutes, Title 19-A, chapter 65, subchapter IV apply. The new provisions apply when only spousal
	28	support, and no child support, is ordered by the court.
	30	This amendment authorizes the payor who is implementing the withholding order to withhold a \$2 processing fee in addition to
	32	the amount withheld for spousal support. This is to cover the costs the employer or other payor of income incurs in complying
	34	with the order.
	36	This amendment limits the activities of the Department of Human Services with regard to income withholding for spousal
	38	support to receiving the specified amounts withheld, recording each amount received and disbursing those amounts to the person
