18 COMMITTEE AMENDMENT "A" to H.P. 1212, L.D. 1712, Bill, "An 20 Act to Create a Citizen Panel on Deregulation"

22 Amend the bill in section 1 in that part designated "<u>§2611.</u>" by striking out all of subsection 2 (page 1, lines 17 to 24 in L.D.) and inserting in its place the following:

 26 '2. Membership. The panel consists of the following 10 public members: Two members appointed by the Governor; 2
 28 appointed by the President of the Senate; 2 appointed by the Speaker of the House; 2 appointed by the minority leader of the
 30 Senate; and 2 appointed by the minority leader of the House. Of the members selected, no more than 4 may be enrolled in the same
 32 political party.'

Further amend the bill in section 1 in that part designated "<u>\$2611.</u>" in subsection 4 in the first and 2nd lines (page 1, lines 37 and 38 in L.D.) by striking out the following: "<u>Except</u> for the legislative members, a" and inserting in its place the following: '<u>A</u>'

40 Further amend the bill in section 1 in that part designated "<u>\$2611.</u>" in subsection 6 in the 6th line (page 2, line 6 in L.D.)
42 by striking out the following: "<u>least 3 members is</u>" and inserting in its place the following: '<u>least 6 members is</u>' and
44 in the 7th line (page 2, line 7 in L.D.) by striking out the following: "<u>least 3 members is</u>" and inserting in its place the
