3. Revocation of certificate. The commissioner may revoke 2 a personal watercraft rental and leasing agent certificate if the commissioner determines that the certificate holder: 4 A. Rented or leased a personal watercraft that was unsafe; 6 <u>or</u> 8 B. Failed to instruct a person intending to rent or lease a personal watercraft on personal watercraft safety. The department shall provide each certificate holder with 10 written materials and instructional guidelines on personal 12 watercraft safety that the certificate holder shall review with each personal watercraft renter or lessor before that 14 person operates that personal watercraft. 16 4. Exception. This section does not apply to: 18 A. Campgrounds licensed by the Department of Human Services that offer the personal watercrafts owned by that campground 20 exclusively for use by campground clientele; 22 Commercial sporting camps. For the purposes of this в. section, "commercial sporting camp" means a business 24 consisting of primitive lodging facilities that offers the public the opportunity to pursue primitive hunting, fishing, 26 boating or snowmobiling activities; or 28 C. A person lawfully engaged in guiding activities under section 7311 who accompanies others on guided trips that 30 include the use of personal watercrafts. Sec. 9. 12 MRSA §7827, sub-§26 is enacted to read: 32 34 26. Unlawfully renting or leasing a personal watercraft. A person is guilty of unlawfully renting or leasing a personal watercraft if that person rents or leases a personal watercraft 36 in violation of section 7825-B. 38 Sec. 10. 12 MRSA §7901, sub-§17 is enacted to read: 40 17. Unlawfully renting or leasing a personal watercraft. A 42 violation of section 7827, subsection 26 is a civil violation for which a forfeiture of not less than \$200 must be adjudged. The 44 \$200 minimum fine may not be waived by the court.'

FISCAL NOTE

The Department of Inland Fisheries and Wildlife will incur some minor additional costs to administer registration and certification of personal watercraft rental agents. These costs will be offset by minor increases in revenue from fees for personal watercraft rental agent certificates.

Committee Amendment "A" requires that motorboat rental and leasing agents obtain a certificate from the Department of Inland Fisheries and Wildlife. This amendment instead requires that personal watercraft rental and leasing agents obtain such a certificate.
