12	The Bureau of Taxation, renamed the Bureau of Revenue Services by this bill, will incur additional expenses as a result of any agreements to collect revenue for other state departments
14	and agencies. The additional costs to provide these collection services will be offset by deductions from the revenue collected
16	by the bureau for other state departments and agencies. The amounts of the additional expenditures and the dedicated revenue
18	generated by the bureau to offset these expenditures can not be estimated at this time. The net impact on the revenues and
20	expenses of the other agencies also can not be determined.
22	This bill includes allocations of \$500 annually in fiscal years 1997-98 and 1998-99 as base allocations to authorize
