SENATE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 1318, L.D. 1868

This amendment increases the cap on total wagers above which the General Fund share is distributed among 3 dedicated funds
administered by the State Harness Racing Commission. Increasing the cap to \$35,000,000 will increase annual General Fund revenues by \$28,760 beginning in fiscal year 1997-98. In addition, there will be an equivalent loss of dedicated revenues distributed to
the 3 funds.
SUMMARY
This amendment increases the cap on total wagers above which
the General Fund share is divided among the commercial meet account, the Sire Stakes Fund and the Stipend Fund. The cap is
increased from \$33,500,000 to \$35,000,000.
