EEE-1. Authorization of purchase, lease or lease-purchase of 28 equipment or land. Notwithstanding the Maine Revised Statutes, Title 5, section 1587, Maine Public Broadcasting Corporation in 30 cooperation with the Treasurer of State is authorized to purchase, lease with an option to purchase or enter into 32 lease-purchase financing agreements for equipment or land needed to enable Maine Public Broadcasting Corporation to implement the 34 federally mandated conversion to digital broadcasting, with an outright purchase price of not more than \$4,500,000. The the Maine Public Broadcasting Corporation is 36 President of authorized to encumber, mortgage and otherwise give security interests in the equipment or land and to provide for reasonable 38 access to the property as part of any financing arrangement 40 authorized by this Part. The term of any lease-purchase agreement may not exceed 10 42 years, totaling \$4,500,000 with interest costs at 6.75% of 44 approximately \$1,700,000.

Sec. EEE-2. 2000-2001 Biennial budget funding. 46 Maine Public Broadcasting Corporation is authorized to include the costs associated with the purchase, lease or lease-purchase agreement 48 authorized by this Part in its current services budget request 50 annually, beginning in the 2000-2001 biennium.'

Further amend the amendment by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

FISCAL NOTE

8 This amendment authorizes the Maine Public Broadcasting Corporation to issue a lease-purchase agreement to finance its 10 conversion to digital broadcasting in an amount not to exceed \$4,500,000 with interest costs at 6.75% of approximately 12 \$1,700,000. This authorization will result in additional debt service costs in its "current services" budget request beginning 14 in fiscal year 1999-2000, resulting in additional requests for General Fund appropriations of approximately \$617,000 annually 16 for 10 years.

SUMMARY

This amendment authorizes the Maine Public Broadcasting 22 Corporation to issue a certificate of participation to finance its conversion to digital broadcasting, as required by federal 24 mandate.
