Recommendations. Resolved: That the Commissioner of Labor, in consultation with the members of the Joint Standing Committee on Labor, the Deaf Advisory Council, the Governor Baxter School for the Deaf, advocacy groups and organizations representing persons who are deaf and hard-of-hearing, and all affected agencies, including but not limited to the Department of Corrections, the Department of Education, the Department of Human Services, the Department of Mental Health, Mental Retardation and Substance Abuse Services, the Department of Public Safety, the

Department of Transportation, the Maine Emergency Management Agency, the Maine Turnpike Authority and the Public Utilities Commission, shall make recommendations to the Governor and the joint standing committee of the Legislature having jurisdiction over labor matters by September 15, 1998 for statutory changes, reorganization or restructuring, and funding as necessary to carry out these recommendations. The joint standing committee may report out legislation as necessary to implement the recommendations of the commissioner to the First Regular Session of the 119th Legislature.'

'FISCAL NOTE

The Department of Labor will incur some minor additional 4 costs to assess the Division of Deafness and to report any subsequent recommendations to the Legislature. These costs can б be absorbed within the department's existing budgeted resources. 8 Several state agencies will incur some minor additional costs to consult with the Department of Labor on the development 10 of recommendations regarding the Division of Deafness. These costs can be absorbed within those agencies' existing budgeted 12 resources.' 14 **SUMMARY** 16 The amendment eliminates the formation of an official

18 subcommittee and adds affected agencies to the list of entities with which the Commissioner of Labor must consult when making 20 recommendations regarding the Division of Deafness. The amendment also adds a fiscal note to the resolve.
