Be it enacted by the People of the State of Maine as follows:

| 1. Endowment Incentive Fund. The Endowment Incentive Fund, |
| referred to in this section as the "fund," is created to provide |
| an incentive for private donations for endowment purposes to and |
| for the benefit of the university and each of its campuses by |
| providing matching state funds for certain private donations for |
| <u>academic purposes. The fund contains amounts appropriated by the</u> Legislature and other money received by or on behalf of the |
| university and its campuses for the purposes of this section. |

| 2. Administration of fund. The fund is administered by the |
| trustees. The trustees shall adopt criteria establishing |
| gualifications for private gifts and grants to be matched from |
| the fund. These criteria must provide that only private |
| donations for academic purposes may qualify for matching. These |
| <u>criteria must:</u> |

| A. Set standards for types of gifts that gualify for |
| matching; |
| B. Establish minimum and maximum amounts for gifts to be |
| matched from the fund; |
| |
| C. Set annual limits on total matching from the fund; |
| |
| D. Establish qualified recipients of private donations |
| eligible for matching funds, including the University of |
| Maine System and each of its campuses, as well as |
| institutionally related foundations qualified under Section |
| 501(c)(3) of the Internal Revenue Code; and |

| E. Establish any other qualifications determined by the |
| trustees to provide the greatest incentive for encouraging |
| private endowment gifts for academic purposes. |

| 3. Distribution of funds. The trustees shall provide that |
| matching funds be available to all campuses of the university |
| according to the formula adopted for the distribution of |
| education and general funds. |
| 4. Reduction prohibited. Appropriations to the fund must |
| be in addition to any other funds appropriated to the university |
| and may not be used to reduce appropriations for other purposes. |
