Amend the amendment in section 5 in the 7th to 10th lines (page 3, lines 1 to 4 in amendment) by striking out the following: "provide funding for direct care workers to be paid an hourly wage of at least \$7.99 per hour and for direct care workers who are paid hourly wages of over \$7.99 to receive a 3% cost-of-living increase." and inserting in its place the following: 'provide a cost-of-living adjustment for direct care workers within the limitations of funding provided in this Act.'

38 This amendment reduces the General Fund cost of the bill by
40 \$2,295,282 in fiscal year 1998-99. It provides General Fund
42 appropriations totalling \$250,000 and a Federal Expenditure Fund
44 allocation of \$322,891 to provide a cost-of-living increase for
46 certain direct care workers. It also includes a repeal of Public
Law 1997, chapter 643, Part GG, which will result in a General
Fund deappropriation of \$100,000 from the University of Maine
System. Part GG provided funding to the University of Maine at
Fort Kent to construct and relocate a facility for forestry and
conservation programs.


