SENATE AMENDMENT "A" to H.P. 1647, L.D. 2277, Bill, "An Act to Implement the Recommendations of the Majority of the Joint Standing Committee on Utilities and Energy Arising from Its Government Evaluation Act Review of the Office of the Public Advocate"

Amend the bill by inserting after the enacting clause the 22 following:

'Sec. 1. 35-A MRSA §116, sub-§8, ¶C-1, as enacted by PL 1993, c. 633, §2 and affected by §3, is amended to read:

Except as specified in this subsection, funds that are C-1. not expended at the end of a fiscal year do not lapse but 28 must be carried forward to be expended for the purposes 30 specified in this section in succeeding fiscal years; but\_ with the exception of funds carried forward from fiscal year 32 1996-97 to fiscal year 1997-98, unexpended funds in excess of 10% of the total annual assessment authorized in this 34 section must, at the option of the Public Advocate, either be presented to the Legislature in accordance with paragraph 36 A for reallocation and expenditure or used to reduce the utility assessment in the following fiscal year. <u>In the</u> 38 case of funds carried forward from fiscal year 1996-97 to fiscal year 1997-98, 100% of these funds may be expended for the purposes specified in this section.' 40
