The 44 Legislature finds that Chapter 6 exceeds the prescriptive authority of naturopathic doctors described in Title 32, section 46 12522. As provisionally adopted, Chapter 6 includes controlled substances that naturopathic doctors may not prescribe pursuant 48 to Title 32, section 12522, subsection 5, paragraph A. SUMMARY

This amendment is the minority report. The amendment 4 replaces the original resolve. The amendment strikes the emergency preamble and emergency clause. The amendment 6 authorizes final adoption of Chapter 5: Standards for Continuing Professional Education for Acupuncturists and Naturopathic 8 Doctors; and Chapter 9: Fees, Section 1. The amendment also disapproves Chapter 6: Standards Relating to Prescriptive 10 Authorities and Collaborative Relationships because that rule exceeds the scope of prescriptive authority described in the 12 licensing statute. The amendment also directs the Department of Professional and Financial Regulation to reconvene a subcommittee 14 of the Board of Complementary Health Care Providers to develop a revised rule within the statutory scope of prescriptive authority. This amendment allows the Department of Professional 16 and Financial Regulation to proceed with licensure of 18 naturopathic doctors, but limits naturopathic doctors' prescriptive authority to nonprescription medications. The 20 amendment also adds an appropriation section and a fiscal note.
