## COMMITTEE AMENDMENT "H" to H.P. 75, L.D. 88

## **SUMMARY**

4 This amendment limits the expansion of the list of mandatory reporters of child abuse to the administrators and counselors at children's summer camps. Other summer camp employees are not included as mandatory reporters. The mandatory reporting law applies to adults only; counselors who are under 18 years of age would not be required to report suspected abuse, although they may do so voluntarily.
