COMMITTEE AMENDMENT "H" to H.P. 108, L.D. 139

Sec. 3. 30-A MRSA §7501, sub-§9 is enacted to read:

9. Animal control. Animal control services. The county commissioners may enact an ordinance for the purpose of animal control. The county commissioners shall give 14 days notice of the meeting at which the ordinance is to be proposed in the manner provided for town meetings.'

Further amend the bill by inserting at the end before the 10 summary the following:

'FISCAL NOTE

This bill may increase the number of civil violations filed in the court system. The additional workload and administrative costs associated with the minimal number of new cases filed can be absorbed within the budgeted resources of the Judicial Department.'

SUMMARY

This amendment authorizes county commissioners of each county to adopt animal control ordinances within the unorganized territory in their county and requires 14 days notice of the meeting at which the proposed ordinance is to be enacted. The amendment also adds a fiscal note to the bill.
