This bill includes a General Fund appropriation of \$200,000 8 in fiscal year 1999-00 for the Maine State Museum to bring an art exhibit currently located in Aomori, Japan to Maine as part of a 10 cultural exchange. No funding for this purpose is currently included in Public Law 1999, chapter 16, the "current services" 12 budget, or in the Governor's proposed "Part 2" budget.

14 This bill also requires the State Controller to transfer \$200,000 in fiscal year 1999-00 from the State Contingent Account 16 back to the unappropriated surplus of the General Fund as a means of funding the appropriation.'

SUMMARY

22 This amendment requires the State Controller to transfer \$200,000 from the State Contingent Account in fiscal year 1999-00 to the unappropriated surplus of the General Fund. This transfer will fund the \$200,000 General Fund appropriation in the same fiscal year to bring an art exhibit in Aomori, Japan to Maine. This amendment clarifies that the appropriation is one-time funding only.
