

2 **Be it enacted by the People of the State of Maine as follows:**

4 **Sec. 1. 12 MRSA §7079-C is enacted to read:**

6 **§7909-C. Duty to exhibit a license or permit**

8 A person who holds a license or permit issued under chapters
10 701 to 721 shall, while engaged in the licensed activity or while
12 transporting fish, wild animals or wild birds:

14 1. Carry license or permit. Have on that person that
16 license or permit; and

18 2. Exhibit license or permit. Exhibit that license or
20 permit upon request to a warden or other law enforcement officer,
22 an employee of the department or the owner of the land on which
24 the licensed activity is taking place.

26 A person who violates this section is guilty of failure to
28 exhibit a license. Failure to exhibit a license is a Class E
30 crime.

52 **SUMMARY**

54 This bill requires a person holding a license or permit
56 issued by the Department of Inland Fisheries and Wildlife to keep
58 that license or permit on that person's person while engaged in
60 the licensed activity or while transporting fish, wild animals or
62 wild birds. The bill also requires the person to exhibit that
64 license or permit upon request to a warden or other law
66 enforcement officer, an employee of the department or the owner
68 of the land on which the licensed activity is taking place.
