	Constitutional referendum procedure; form of question; effective
34	date. Resolved: That the municipal officers of this State shall
	notify the inhabitants of their respective cities, towns and
36	plantations to meet, in the manner prescribed by law for holding
38	a statewide election, at a statewide election, on the Tuesday following the first Monday of November following the passage of
20	this resolution, to vote upon the ratification of the amendment
40	proposed in this resolution by voting upon the following question:
42	"Do you favor amending the Constitution of Maine to require
72	a $2/3$ vote of all the members of each branch of the

48	The legal voters of each city, town and plantation shall
70	vote by ballot on this question and designate their choice by a

cross or check mark placed within the corresponding square below
the word "Yes" or "No." The ballots must be received, sorted, counted and declared in open ward, town and plantation meetings
and returns made to the Secretary of State in the same manner as votes for members of the Legislature. The Governor shall review
the returns and, if it appears that a majority of the legal votes are cast in favor of the amendment, the Governor shall proclaim
that fact without delay and the amendment becomes part of the Constitution on the date of the proclamation; and be it further

Secretary of State shall prepare ballots. Resolved: That the Secretary of State shall prepare and furnish to each city, town and plantation all ballots, returns and copies of this resolution necessary to carry out the purpose of this referendum.

## SUMMARY

This bill proposes an amendment to the Constitution of Maine 20 to require approval of 2/3 of each House of the Legislature to enact or increase taxes or license fees except when inadequate 22 funds have been appropriated for debt payment.
