## **10 APPROPRIATIONS/ALLOCATIONS**

14 This resolve will result in the transfer of a historical property currently owned by the Bureau of Parks and Lands within 16 the Department of Conservation to the Friends of Montpelier. The deed and gift agreement requires that the property and historical 18 collections be used exclusively for historic preservation and public education purposes. The department will not realize any 20 financial gain from the transfer of this property.

The Bureau of Parks and Lands will realize some savings in General Fund expenditures due to decreased property and theft insurance payments. Due to the timing of the property transfer, the estimated savings will be minor in fiscal year 1999-00 and \$1,805 in fiscal year 2000-01. This bill includes a General Fund deappropriation of \$1,805 in fiscal year 2000-01. If the reversion clause is exercised in the future, these savings will no longer be realized.'

**SUMMARY** 

34 This amendment requires the contract conveying the property to contain a reversion clause. It also adds a deappropriation 36 and a fiscal note to the resolve.
