## **'FISCAL NOTE**

4 The Department of Inland Fisheries and Wildlife will incur some minor additional costs to amend certain rules and to submit a required report to the Legislature. These costs can be 6 absorbed within the department's existing budgeted resources. 8 This bill may reduce prosecutions for Class E crimes. If 10 the number of jail sentences is reduced, the savings to the counties are estimated to be \$82.48 per day per prisoner. The 12 amount of any reduction of jail time and the resulting savings to the county jail system are expected to be insignificant. 14 The Judicial Department may realize some minor savings from 16 reductions of workload and administrative costs associated with the minimal number of cases that will no longer be filed in the 18 court system. Reductions in the collection of fines may decrease General Fund revenue by minor amounts.' 20 22 SUMMARY 24 This amendment replaces the bill. The amendment broadens the authority of the Commissioner of Inland Fisheries and 26 Wildlife with respect to extending the open-water fishing season. The amendment also requires the commissioner to report 28 to the Joint Standing Committee on Inland Fisheries and Wildlife by February 15, 2000 on any rule-making activities taken or 30 anticipated under that new authority. The amendment also adds a fiscal note to the bill.
