SUMMARY

This bill exempts from the Propane and Natural Gas Act self-service propane or natural gas dispensing stations that dispense fuel into a clean fuel vehicle through pumps that have been certified to standards of safety equivalent to those applicable to gasoline delivery pumps certified for self-service operation by any motor vehicle operator.
