## **FISCAL NOTE**

10 The State Planning Office will incur some minor additional costs to make reports at least annually to the Legislature.
12 These costs can be absorbed within the office's existing budgeted resources. The office also will incur some minor additional
14 costs in fiscal year 2000-01 as a result of the earlier review of the office under the State Government Evaluation Act.'

**SUMMARY** 

20 This amendment is the majority report of the Joint Standing Committee on State and Local Government. The amendment amends 22 the original bill by requiring that the Senate, rather than the entire Legislature, confirm the appointment of the Director of 24 The amendment also retains the the State Planning Office. current requirement that the Governor fix the director's salary. 26 It also removes a requirement from the original bill that the Director of the State Planning Office advise the Legislature on 28 policy matters. The amendment also retains a requirement in current law that the director report annually to the Governor and 30 it removes a requirement that the director report annually to the joint standing committee having jurisdiction over state and local 32 government matters on allocations to an expenditures by the State Planning Office. The amendment also adds a fiscal note.
