SUMMARY

This amendment exempts gasoline sold in Washington and Aroostook counties from the increase in the gasoline tax; increases the tax by 1 ¢ per gallon for gasoline sold in Hancock, Penobscot, Piscataquis and Somerset counties; and increases the tax by 4 ¢ per gallon for gasoline sold in all the other counties in this State.
