#### Be it enacted by the People of the State of Maine as follows:

Sec. 1. 12 MRSA §7463-A, sub-§4-A, as repealed and replaced by 4 PL 1993, c. 574, §22, is amended to read:

Subpermittees. A person may not hunt moose with a 6 4-A. permittee unless the person is a subpermittee authorized in 8 accordance with this subsection. An applicant for a moose permit may indicate on the application filed pursuant to subsection 6 10 the name of a subpermittee-designate and the name of an alternate If the applicant is issued a moose subpermittee-designate. 12 permit under subsection 7, the subpermittee-designate becomes a subpermittee and the permittee may authorize the subpermittee to 14 participate in the moose hunt with the permittee. The permittee may authorize the alternate subpermittee-designate to participate 16 in the hunt in place of the subpermittee-designate if the permittee notifies the department of the authorization at least 5 18 business days prior to the first day of the moose season, in which case, the alternate subpermittee-designate becomes the 20 subpermittee. Whether or not a permittee indicates on the application filed pursuant to subsection 6 the name of a 22 subpermittee-designate, the permittee may designate a subpermittee or change the designation of a subpermittee if the 24 permittee notifies the department of the name of the subpermittee at least 5 business days prior to the first day of the moose 26 season. The permittee may choose not to authorize a subpermittee to participate in the hunt, but a subpermittee must always be in 28 the presence of the permittee while hunting moose. Α subpermittee is not in the presence of the permittee if contact between the permittee and the subpermittee requires visual or 30 audio enhancement devices, including binoculars or citizen band 32 radios. A permittee may hunt moose with no more than one authorized subpermittee. 34

#### SUMMARY

38 This bill allows a person who is awarded a moose permit to name a subpermittee after the moose lottery if that person 40 notifies the Department of Inland Fisheries and Wildlife of the name of the subpermittee at least 5 business days prior to the 42 first day of the moose season.
