30	Pursuant to the Constitution of Maine, Article IX, Section 21, two thirds of all of the members elected to each House have
32	determined it necessary to enact this measure.'

'A legislative vacancy occurring on the budget committee must be filled by the Androscoggin County legislative delegation for the balance of the unexpired term.'

Further amend the bill by relettering or renumbering any 16 nonconsecutive Part letter or section number to read consecutively.

## **'FISCAL NOTE**

This bill requires the size of the Androscoggin County budget committee to be increased by 2 members of the Androscoggin County legislative delegation. The additional costs of this state mandate are expected to be minor. Pursuant to the Mandate Preamble, the two-thirds vote of all members elected to each House exempts the State from the constitutional requirement to fund 90% of the additional local costs.'

## **SUMMARY**

36 This amendment amends the original bill by requiring that the 2 legislative members of the budget committee be elected by 38 the Androscoggin County legislative delegation and that any vacancy in legislative seats on the budget committee be filled by 40 the Androscoggin County legislative delegation. It also adds a mandate preamble and a fiscal note.
