COMMITTEE AMENDMENT "A" to H.P. 806, L.D. 1129, Bill, "An Act to Amend the Laws Pertaining to the Maine HIV Advisory Committee"

Amend the bill by striking out all of section 1.

Further amend the bill in section 7 in subsection 3-A by striking out all of the last sentence (page 4, lines 44 to 47 in L.D.)

Further amend the bill by striking out all of section 10.

Further amend the bill in section 12 in the 2nd line (page 5, line 27 in L.D.) by striking out the following: "section 11" and inserting in its place the following: 'section 9'

Further amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

Further amend the bill by inserting at the end before the summary the following:

FISCAL NOTE

The Department of Education, the Department of Corrections, and the Department of Public Safety will incur some minor additional costs to participate as members of the committee.

2 These costs can be absorbed within the existing budgeted
resources of each department. The additional costs associated
4 with submitting the required report can be absorbed by the
Department of Human Services utilizing existing budgeted
resources.

8 The Department of Human Services does not currently budget
funds for the Maine HIV Advisory Committee nor has the department
received any requests from members for reimbursement of meeting
10 expenses. Therefore, the reduction in the number of members is
not expected to have any impact on the costs associated with this
12 committee.'

18 The amendment strikes from the bill the provisions for
paying per diem for certain members of the commission. It also
strikes a provision authorizing the commission to accept gifts,
20 grants and other funding, since current law already authorizes
the commission to vote to accept gifts, grants and other
22 funding. The amendment also adds a fiscal note to the bill.
