32 This amendment replaces the resolve. The amendment requires Commissioner Inland Fisheries Wildlife the of and to comprehensively review the issue of expanding hunting and fishing 34 opportunities to disabled persons and to report the findings and 36 recommendations to the Joint Standing Committee on Inland Fisheries and Wildlife by January 1, 2001. The report must include a review of the department's current authority to issue 38 unconventional or special privilege licenses for any type of disability, including temporary disabilities, and the criteria 40 and standards used by the Department of Inland Fisheries and Wildlife to determine eligibility for such licenses. The report 42 must also include recommendations for improving the promotion of 44 hunting and fishing opportunities in the State to the disabled community, on the use of special or group hunts or special seasons for the disabled, on allowing another person to assist a 46 disabled person to hunt or fish and on methods to address any safety issues that may be associated with hunting or fishing by 48 disabled persons.
