SENATE AMENDMENT " A" to COMMITTEE AMENDMENT "A" to H.P. 871, L.D. 1228, Bill, "An Act to Increase Payments to Foster Parents"

Amend the amendment by inserting before the first paragraph the following:

'Amend the bill in section 1 in the 3rd line (page 1, line 5 in L.D.) by inserting after the following: "month" the following: 'effective October 1, 2000'

Further amend the amendment in the first paragraph after the title in the first line (page 1, line 22 in amendment) by striking out the following: "Amend" and inserting in its place the following: 'Further amend'

Further amend the amendment in section 2 by striking out all of the 3rd line (page 1, line 27 in amendment) and inserting in its place the following:

'2000-01'

Further amend the amendment in section 2 in that part designated "HUMAN SERVICES, DEPARTMENT OF" in that part relating to "Child Welfare Services" by striking out all of the 2nd line (page 1, line 33 in amendment) and inserting in its place the following:

'All Other \$296,505'

SENATE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 871,
L.D. 1228

Further amend the amendment in section 2 in that part designated "HUMAN SERVICES, DEPARTMENT OF" in that part relating to "Foster Care" by striking out all of the 2nd line (page 1, line 40 in amendment) and inserting in its place the following:

'All Other \$164,766'

Further amend the amendment in section 2 by striking out all of the last line (page 1, line 46 in amendment) and inserting in its place the following:

'TOTAL \$461,271'

Further amend the amendment in section 3 by striking out all of the 3rd line (page 2, line 5 in amendment) and inserting in its place the following:

'2000-01'

Further amend the amendment in section 3 in that part designated "HUMAN SERVICES, DEPARTMENT OF" in that part relating to "Foster Care" by striking out all of the 2nd line (page 2, line 11 in amendment) and inserting in its place the following:

'All Other \$319,839'

FISCAL NOTE

This amendment reduces the General Fund appropriations by \$461,271 and \$215,259 in fiscal years 1999-00 and 2000-01, respectively. This amendment also reduces the Federal Expenditures Fund allocations by \$319,839 in fiscal year 1999-00 and \$149,258 in fiscal year 2000-01.

SUMMARY

This amendment changes the effective date of the increase to
October 1, 2000 and changes the appropriations and allocations to
reflect this change.
