.7	As amended, this bill may increase prosecutions for Class E
16	crimes. If a jail sentence is imposed, the additional costs to
18	the counties are estimated to be \$83.36 per day per prisoner. The number of prosecutions that may result in a jail sentence and the resulting costs to the county jail system are expected to be
20	insignificant.
22	SUMMARY
24	
26	This amendment removes the October 31, 2002 sunset on the law permitting commercial large game shooting areas and the provisions that make operation of a commercial shooting area a
28	crime beginning October 31, 2002. The amendment also prohibits
30	the issuance of licenses to corporations and restricts the transfer of a license to a member of the license holder's immediate family only.
