SENATE AMENDMENT "D" to COMMITTEE AMENDMENT "A" to S.P. 457, L.D. 1332, Bill, "An Act to Prohibit Hunting Animals in Enclosed Areas"

Amend the amendment in section 3 in that part designated "~~S~~1342." in the first paragraph in the last line (page 3, line 6 in amendment) by inserting after the following: "section." the following: 'A license may be issued only to an individual or partnership. A license may not be issued to a corporation.'

Further amend the amendment in section 3 in that part designated "~~S~~1342." by striking out all of subsection 5 (page 4, lines 17 to 20 in amendment) and inserting in its place the following:

'5. Transfer of license. A person may transfer a license issued in accordance with this section. The license holder must notify the commissioner 30 days prior to a transfer informing the commissioner of the date of the transfer and the name, mailing address and telephone number of the person receiving the transferred license.'

Further amend the amendment in section 3 by striking out all of that part designated "~~S~~1346." (page 6, lines 23 to 25 in amendment)

Further amend the amendment in section 9 in paragraph G in the last line (page 8, line 30 in amendment) by striking out the following: "er" and inserting in its place the following: 'or'

Further amend the amendment by striking out all of sections 10 and 11.

**SENATE AMENDMENT**

SENATE AMENDMENT "D" to COMMITTEE AMENDMENT "A" to S.P. 457,  
L.D. 1332

Further amend the amendment in section 13 in paragraph G in  
the last line (page 9, line 19 in amendment) by striking out the  
following: "or" and inserting in its place the following: 'or'

Further amend the amendment by striking out all of sections  
14, 15 and 17.


Further amend the amendment by relettering or renumbering  
any nonconsecutive Part letter or section number to read  
consecutively.

### FISCAL NOTE

As amended, this bill may increase prosecutions for Class E  
crimes. If a jail sentence is imposed, the additional costs to  
the counties are estimated to be \$83.36 per day per prisoner.  
The number of prosecutions that may result in a jail sentence and  
the resulting costs to the county jail system are expected to be  
insignificant.

### SUMMARY

This amendment incorporates the changes made by Senate  
Amendment "C" to Committee Amendment "A" to L.D. 1332, except  
that it removes the provision that restricts the transfer of a  
license to a member of the license holder's immediate family only.
