## **COMMITTEE AMENDMENT**

COMMITTEE AMENDMENT " / " to H.P. 1012, L.D. 1423

3. Adds a provision establishing titles and salary ranges for 6 positions in the Office of the Public Advocate;

4. Changes a provision of the Maine Revised Statutes, Title
35-A to bring it into conformity with the changes made by the bill;

5. Corrects the allocation section of the bill to reflect 10 the actual costs of funding the expansion of the Office of the Public Advocate; and

6. Adds a fiscal note to the bill.

The bill, as amended, adds 3 positions to the Office of the Public Advocate, increasing the Public Advocate's staff from 6 to 9 positions. It also reclassifies the positions and increases 18 the salary of the existing 6 employees of the Office of the Public Advocate and establishes their salary ranges in law. It 20 also establishes in law the salary ranges of 2 of the 3 new positions.
