COMMITTEE AMENDMENT "H" to H.P. 1073, L.D. 1520

F. By January 1, 2000, the board shall adopt, at a minimum, the universal waste rules, excluding pesticides, promulgated by the United States Environmental Protection Agency as defined in 40 Code of Federal Regulations, Parts 9, 260, 261, 262, 264, 265, 266, 268, 270 and 273.

**Emergency clause.** In view of the emergency cited in the 8 preamble, this Act takes effect when approved.'

## **'FISCAL NOTE**

16 The Board of Environmental Protection within the Department of Environmental Protection will incur some minor additional 18 costs to adopt certain rules pertaining to universal waste. These costs can be absorbed within the board's existing budgeted 20 resources.'

## SUMMARY

This amendment requires the Board of Environmental Protection, by January 1, 2000, to adopt the United States Environmental Protection Agency universal waste rules regarding batteries and further requires the Board of Environmental Protection to adopt rules regarding other universal wastes, excluding pesticides. This amendment also adds a fiscal note to the bill.
