## SUMMARY

This amendment redrafts the bill for clarity and makes the following substantive changes.

- 1. It permits the board of trustees of the Veazie Sewer District to set the salaries of the trustees provided that the chair of the board may not receive more than \$500 per year and the other trustees may not receive more than \$400 per year.
- 2. It removes the requirement that the trustees establish in the district bylaws the time and place of the annual meeting; the trustees are authorized, as in the bill, to establish the date of the annual meeting.
