COMMITTEE AMENDMENT "A" to H.P. 1110, L.D. 1569, Bill, "An Act to Amend the Charter of the Veazie Sewer District"

Amend the bill by striking out all of section 1 and inserting in its place the following:

'Sec. 1. P&SL 1951, c. 114, §7, 3rd ¶ is amended to read:

~~The trustees shall serve without compensation, except that the treasurer may receive for his services an amount to be fixed by the board of trustees not in excess of \$100 per year.~~
Notwithstanding the Maine Revised Statutes, Title 38, section 1252, the trustees receive compensation as fixed by the board of trustees, except that the chair of the board of trustees may receive not more than \$500 per year and the other trustees may receive not more than \$400 per year. The treasurer shall give bond to the district in such sum and with such sureties as the trustees may determine, which bond shall remain remains in the custody of the chairman chair. The treasurer's salary, bond premium and all expenses of the district shall must be paid from funds of the district.'

Further amend the bill in section 2 in section 12 in the 3rd line (page 1, line 20 in L.D.) by striking out the following: "on the" and inserting in its place the following: 'on the'

Further amend the bill in section 2 in section 12 in the 4th line (page 1, line 21 in L.D.) by inserting after the following: "year," the following: 'date and'

Further amend the bill in section 2 in section 12 in the 4th line (page 1, line 21 in L.D.) by striking out the following: "such" and inserting in its place the following: 'such the'

line (page 1, line 22 in L.D.) by striking out the following: ",

8 **SUMMARY**

10 This amendment redrafts the bill for clarity and makes the
following substantive changes.

14 1. It permits the board of trustees of the Veazie Sewer
District to set the salaries of the trustees provided that the
chair of the board may not receive more than \$500 per year and
16 the other trustees may not receive more than \$400 per year.

18 2. It removes the requirement that the trustees establish
in the district bylaws the time and place of the annual meeting;
20 the trustees are authorized, as in the bill, to establish the
date of the annual meeting.
