expenses to contract for special expert witnesses and costs for
legal representation from the Department of the Attorney General and could exceed \$3,500 in total costs for each hearing required.

This bill also may increase prosecutions for Class D crimes. If a jail sentence is imposed, the additional costs to the counties are estimated to be \$82.48 per day per prisoner. These costs are not reimbursed by the State. The number of prosecutions that may result in a jail sentence and the resulting costs to the county jail system are expected to be insignificant.

12 In addition to these criminal cases, this bill also may increase the number of civil suits filed in the court system. 14 The additional workload, administrative costs and indigent defense costs associated with the minimal number of new cases filed in the court system can be absorbed within the budgeted 16 Judicial Department. resources of the The collection of additional filing fees and fines may also increase General Fund 18 revenue by minor amounts.'
