	ATLANTIC SALMON MANAGEMENT

	§7641. Powers
10	
10	The commissioner has the sole authority to manage the
12	Atlantic salmon fishery in the State, including the sole
	authority to introduce Atlantic salmon into inland waters, other
14	than commercial aquaculture facilities and associated
16	activities. The commissioner has the sole authority to limit or
16	prohibit the taking of Atlantic salmon, issue licenses for the
10	taking of Atlantic salmon and adopt rules establishing the time,
18	place and manner of Atlantic salmon fishing in all waters of the
20	State. In addition, the commissioner may:

	4. Property. Subject to other applicable requirements of
40	law, acquire, install, construct, operate, manage, sell and
	convey interests in real and personal property, including,
42	without limitation, lands, dams, buildings, facilities,
	structures, flowage rights, mill privileges, easements and
44	rights-of-way, as the commissioner finds necessary to carry out
	the purposes of this chapter, as long as prior rights of
46	municipalities are not affected by the requirements.

	 Fund established. The Atlantic Salmon Fund, referred to
2	in this section as the "fund," is established as a dedicated, nonlapsing fund.

	2. Source of funds. The fund may receive funds from any

8	3. Purpose. The commissioner may use the fund for the
	management and conservation of Atlantic salmon as described in
10	this chapter.
12	§7643. Head of tide; Union River
14	For the purposes of this chapter, head of tide on the Union
10	River, Hancock County, is designated as that point on the
16	downstream side where the highway bridge on U.S. Route 1 crosses the river in the City of Ellsworth.

20	
	1. License required. Except as otherwise provided in this
22	section, a person may not fish for, take, possess, ship or
24	<u>transport Atlantic salmon taken from any state waters without a current Atlantic salmon license.</u>
26	2. License fees. The commissioner shall issue Atlantic
	salmon licenses to fish for Atlantic salmon in inland and coastal
28	waters of the State in accordance with the following provisions.
30	A. The fee for an Atlantic salmon license is \$15 for a
	resident.
32	
	B. The fee for an Atlantic salmon license for any
34	nonresident is:
36	(1) For a season license for a nonresident 16 years of
	age or older, \$30;
38	
	(2) For a 3-day license for a nonresident 16 years of
40	age or older, \$15. This license may not be exchanged
	for a season license; and
42	
	(3) For a nonresident under 16 years of age, \$5.
44	
	C. Members of the State's Indian tribes and state residents
46	under 16 years of age are exempt from any fee.
48	3. License limitations and validation. A person may not
	purchase more than one Atlantic salmon license in any single
50	calendar year for that person's use. Immediately after issuance

2	of an Atlantic salmon license, the purchaser must sign it in the space provided. An unsigned license is considered invalid.
4	4. Atlantic salmon; possession, buying or selling. A person may not possess, buy or sell Atlantic salmon unless each
6	<u>fish is clearly:</u>
8	A, Tagged with an Atlantic salmon tag provided by the commissioner if caught in state waters;
10	B. Tagged with a New Brunswick, Quebec, Nova Scotia or
12	Newfoundland-Labrador Atlantic salmon tag if imported from those Canadian provinces;
14	C Identified by a color receipt loss then 24 hours ald
16	C. Identified by a sales receipt less than 24 hours old;
18	D. For wholesale and retail seafood dealers, identified by a bill of sale indicating numbers of fish purchased, dates of purchase and point of origin of all fish purchased; or

22	E. Tagged as provided in this section. 5. Exceptions. This section does not apply to a person
24	licensed to engage in the aquaculture of Atlantic salmon; however, that person shall report to the commissioner the number
26	and weight of and the locations to which sold of all Atlantic salmon within the commissioner's jurisdiction. The commissioner
28	shall maintain those records as confidential documents.
30	6. Agent's fee. Any clerk or agent appointed by the commissioner to issue an Atlantic salmon license shall retain \$1
32	for each license issued.
34	7. Use of license fees. All license fees must be deposited in the Atlantic Salmon Fund established under section 7642.
36	8. Duplicates. The commissioner or the commissioner's
38	agents shall issue a duplicate license to any person whose license was accidentally lost or destroyed. The fee for a
40	replacement license is \$1, all of which is retained by the
42	issuing agent. Atlantic salmon tags bearing the license number of a lost or destroyed license are invalid.
44	9. Fishing in inland waters. When fishing in inland waters, the holder of a license authorized under this section is
46	subject to all the provisions of this chapter, chapters 701 to 711 and chapters 713 to 721.

50	\$7645. Registration of Atlantic salmon

	Except as provided in subsection 4, a person may not
2	possess, ship or transport an Atlantic salmon that has not been
	properly registered according to the provisions of this section
4	by the person who killed the fish.
б	1. Time period. A person who kills Atlantic salmon shall
	present the Atlantic salmon for registration within 12 hours.
8	The Atlantic salmon must be registered at the first open Atlantic
	salmon registration station on the route taken by the person who
10	kills the fish.
12	2. Information requirements. The person who kills the fish
	must register the fish in the person's own name, Information
14	<u>concerning each Atlantic salmon registered must be reported</u>
	accurately and truthfully.
16	
	3. Possession of unlabeled parts prohibited. A person may
18	not possess any part of an Atlantic salmon taken from the inland
20	or coastal waters of this State unless each part is plainly
20	labeled with the name and address of the person who registered
	the fish, except that a person may possess a fish properly
22	identified under this chapter.
24	4. Exemptions. The following are exempt from the
	registration requirements of this section:

	A. Atlantic salmon imported from outside the State;

	B. Atlantic salmon imported by taxidermists solely for
30	taxidermy purposes; and
32	C. Atlantic salmon raised by means of aquaculture.

34	5. Recreational fishing provision. A person engaged in
26	recreational fishing who takes an Atlantic salmon shall affix to
36	each fish an identification tag designating the date, location
38	and name of the person who caught the fish. The person shall notify the commissioner within 24 hours of that person's first

	<u>§7646. Atlantic salmon imports; exemption from prohibition for</u>
42	fisheries enhancement
44	The commissioner may grant an exemption from the provisions
	of section 6071, subsection 4 for Atlantic salmon, live or eggs,
46	imported for the purpose of enhancing the State's Atlantic salmon
	fisheries.

	<u>§7647. Atlantic salmon; limits; method of taking; closed season</u>
50	

2	Unless otherwise provided by rule adopted by the commissioner, a person may not:
4	1. Minimum length. Take or possess Atlantic salmon that are less than 14 inches in total length;
6	
8	2. Method of taking. From May 1st to October 15th, take Atlantic salmon in state waters by means other than hook and line with an unweighted salmon fly. An Atlantic salmon taken by any
10	other means must be immediately released;
12	3. Closed season. From October 16th to April 30th, take Atlantic salmon from state waters by any means;
14	
16	4. Bag limit. Take more than one Atlantic salmon in one day from state waters. No more than 5 Atlantic salmon per person may be taken annually from all waters of the State; or
18	
20	5. Disposition. Sell or offer for sale any Atlantic salmon taken from state waters, except Atlantic salmon lawfully raised by means of aquaculture.

24	Sec. 2. 12 MRSA Pt. 12, as amended, is repealed.
24	Sec. 3. Transition. All rules adopted by the Atlantic Salmon
26	Authority remain in effect after the effective date of this Act until amended or repealed by the Commissioner of Inland Fisheries
28	and Wildlife. All property owned by the Atlantic Salmon Authority on the effective date of this Act becomes the property
30	of the Department of Inland Fisheries and Wildlife. All contracts, agreements and obligations entered into by the
32	Atlantic Salmon Authority by the effective date of this Act become contracts, agreements and obligations of the Department of
34	Inland Fisheries and Wildlife.

38	SUMMARY
40	This bill repeals the Atlantic Salmon Authority and transfers the authority's powers to the Department of Inland Fisheries and Wildlife.
