Absent the provisions in section 7 of 30 the resolve, these proceeds would accrue to the General Fund. The amount of additional General Fund revenue and dedicated 32 revenue from the proceeds of the sales of these State-owned properties can not be determined at this time. Allocations will 34 be required to authorize expenditures from the amounts set aside in the Bureau of General Services - Capital Construction and 36 Improvements Reserve Fund. The amount and timing of the additional allocations required also can not be determined at 38 this time. If the construction project of the Department of Corrections 40 in the Town of Warren requires the purchase of land for mitigation purposes, funds for this purchase will be available as 42 part of the existing Maine Governmental Facilities Authority 44 funding of that construction project.' 46 **SUMMARY** 48 This amendment changes the title of the resolve and makes 50 several changes that authorize the purchase of property in the
