An Act to Improve the Licensing Procedures for Veterinarians.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 32 MRSA §4859, sub-§4, as amended by PL 1997, c. 246, §11, is further amended to read:

- Establish schedule of fees. 6 4. Establish a schedule of fees for the licensing of veterinarians and registration of The board shall set the fees in an 8 veterinary technicians. amount not to exceed \$150 for veterinarians and \$75 for 10 veterinary technicians. Upon application for license renewal by a veterinarian who no longer maintains an active practice but wishes to continue to remain licensed, the board, upon review of 12 each individual's circumstances, may set an inactive license fee 14 not to exceed \$25.

All licenses expire annually on a date designated by the 22 commissioner and must be renewed with the board by payment of a renewal fee established by the board. At least 60 days before 24 the expiration of a current license, the board shall mail to each licensee at the licensee's last known address a notice of the requirement to renew the license with appropriate application 26 forms for the renewal. If, within 30 days before the expiration 28 of a licensee's current license, the licensee fails to return to the board a completed application either to renew the license or 30 to withdraw from licensure, the board shall notify the licensee as soon as possible at the licensee's last known address that the 32 license renewal is past due. Thirty days after the notice has been sent, if the application has neither been submitted by the 34 licensee nor returned by the United States Postal Service as undeliverable, the board shall notify the licensee by certified 36 mail, return receipt requested, that the licensee's license has been administratively suspended for 30 days. If the certified 38 mail receipt shows that the licensee has received notice of suspension and an administratively complete relicensure application is not submitted within the 30-day period of 40 administrative suspension, the license immediately and 42 automatically lapses. If a certified mail receipt is not received by the board, the administrative suspension of the 44 license is extended for a period of one year from the expiration date of the license, after which the license immediately and 46 automatically lapses.

48 An administratively suspended license may be renewed upon payment of a late fee of \$10 in addition to the renewal fee and 50 submission of an administratively complete relicensure application.

	<u>When a license has lapsed, a formerly licensed veterinarian</u>
2	may be reinstated upon payment of a reinstatement application
	processing fee of \$100. The applicant is subject to all
4	requirements governing new applicants under this chapter, except
	that the board, giving due consideration to the protection of the
6	public, may waive examination if that renewal application is made
	within 2 years of the expiration date of the lapsed license.

	By rule the board may waive the payment of the registration
10	renewal fee of a licensed veterinarian during the period that the
	applicant is on active duty with any branch of the Armed Services
12	of the United States, not to exceed the longer of 3 years or the
	duration of a national emergency.

16	SUMMARY

18	The Board of Veterinary Medicine recently placed in effect a
	major increase in license fees. This bill enables the board to
20	charge a lesser fee for the veterinarians who are no longer
	engaged in active practice but who want to remain licensed.

	This bill also clarifies administrative procedures for the
24	relicensing of veterinarians by establishing provisions very
	similar to those governing the relicensing of physicians.
