SENATE AMENDMENT " A " to COMMITTEE AMENDMENT "A" to H.P. 1311, L.D. 1872, Bill, "An Act to Establish Municipal Cost Components for Unorganized Territory Services to be Rendered in Fiscal Year 1999-00"

Amend the amendment in the 3rd indented paragraph after the title in the 4th line (page 1, line 39 in L.D.) by striking out the following: "46,136" and inserting in its place the following: '51,136'

Further amend the amendment in the 5th indented paragraph after the title in the 4th line (page 1, line 51 in L.D.) by striking out the following: "\$3,394,068" and inserting in its place the following: '\$3,399,068'

Further amend the amendment in the 6th indented paragraph after the title in the 4th line (page 2, line 5 in L.D.) by striking out the following: "\$14,030,055" and inserting in its place the following: '\$14,035,055'

Further amend the amendment in the 7th indented paragraph after the title in the 4th line (page 2, line 11 in L.D.) by striking out the following: "\$14,030,055" and inserting in its place the following: '\$14,035,055'

Further amend the amendment in the 8th indented paragraph after the title in the 4th line (page 2, line 17 in L.D.) by striking out the following: "\$11,678,347" and inserting in its place the following: '\$11,683,347'

Further amend the bill by inserting after section 1 the following:

2 'Sec. 2. Use of funds. Of the county reimbursements for  
services for Hancock County provided in this Act, \$5,000 is for

**'FISCAL NOTE**

12 This amendment increases the amount to be raised from  
property taxes in the unorganized territory of Hancock County by  
14 \$5,000 for fiscal year 1999-00. This increase will not affect  
budgeted General Fund revenue or appropriations. It will  
16 increase the amounts collected as dedicated revenue and paid out  
to Hancock County. No adjustment of allocations is required.'


