Policing Institute to report annually to the joint standing
committee of the Legislature having jurisdiction over criminal justice matters. The amendment specifies that the Judicial
Department may incur up to \$11,000 in fiscal years ending June 30, 2000 and June 30, 2002 to implement the new surcharge. It
also provides that the surcharge created to fund the Maine Community Policing Institute is repealed on September 30, 2001.
The amendment also adds an allocation section and a fiscal note to the bill.
