'The Notwithstanding the Maine Revised Statutes, Title 35-A, section 6410, subsection 7, the compensation of the chair may not exceed \$600 per year and the compensation of the other trustees shall may not exceed \$50 \$500 each per year, unless otherwise provided by vote, as above provided.'

SUMMARY

10 This amendment updates the description of the territory of the district to clarify the boundaries of the district. This amendment also replaces that portion of the bill addressing the salaries of trustees of the Norridgewock Water District. Under 14 this amendment, the chair of the board may receive up to \$600 per year and the other trustees may receive up to \$500.
