'Sec. 4. Chairs; officers. Resolved: That the first named Senate member is the Senate chair, and the first named House of
 Representatives member is the House chair. The committee may select other officers and designate their duties; and be it
 further'

'Sec. 7. Staff. Resolved: That upon approval of the
Legislative Council, the Office of Policy and Legal Analysis shall provide necessary staffing services to the committee. The
Department of Inland Fisheries and Wildlife shall provide assistance to the committee as required by the chairs of the
committee; and be it further

Sec. 8. Compensation. Resolved: That members of the committee who are Legislators are entitled to receive the legislative per diem, as defined in the Maine Revised Statutes, Title 3, section 2, for each day's attendance at meetings of the committee. Public members who are not otherwise compensated by their employer or other entities whom they represent are entitled to receive reimbursement of necessary expenses for their attendance at meetings of the committee. The Executive Director of the Legislative Council shall administer the committee's budget; and be it further'

Further amend the resolve in section 9 in the 4th line (page 38 3, line 31 in L.D.) by striking out the following: "January 15, 2001" and inserting in its place the following: 'December 15, 40 2000' '
