This bill requires the establishment of a citizen participation center in the State House. This bill includes an additional General Fund appropriation of \$23,223 in fiscal year 2000-01 for the Legislature for a Legislative Information Associate position to staff the citizen participation center during legislative sessions. The estimated future costs in fiscal years 2001-02 and 2002-03 for this position will be approximately \$21,928 and \$25,246, respectively. The additional costs associated with staffing the center during the interim between legislative sessions can be absorbed by the Legislature utilizing existing budgeted resources.

The Legislature will also require additional General Fund appropriations for furniture, supplies and equipment for the center and may require funds for the potential costs for renovations. These amounts can not be determined at this time.'

This amendment is the minority report and removes all references to "lobby" from the original bill, including its title. In some instances, the amendment substitutes the word "participation" for the word "lobby." The amendment also makes a technical correction. The amendment also adds an appropriation and a fiscal note to the bill.
